- Two additional copies for EACH defendant and one copy for the plaintiff listed on the <u>Complaint for</u> <u>Eviction</u> and any other paperwork being filed at that time.
- Filing fee

TO REQUEST THE PROPERTY BE RETURNED TO PLAINTIFF, YOU WILL NEED:

- Completed Praecipe for Writ of Restitution.
- Filing fee

Note: Once the **Writ of Restitution** is prepared by the clerk and forwarded to the bailiff for service. The bailiff will call the property owner or owner's counsel listed as point of contact on the <u>Praecipe for Writ of Restitution</u>. This process is solely enforced by the bailiff. Please do not contact the clerks regarding the move-out status.
